THE PROGRAM, CONDUCTED BY LICENSED HEALTHCARE PROFESSIONALS, OFFERS OCCUPATIONAL THERAPY (OT), PHYSICAL THERAPY (PT) AND SPEECH-LANGUAGE PATHOLOGY (SLP) THAT INCORPORATES HIPPO THERAPY AS ONE OF THE TREATMENT TOOLS/STRATEGIES IN THE OVERALL THERAPY PLAN.
